TRRA will allow other groups, particularly student crews of either major tenants or affiliate groups to lease TRRA equipment under the following terms:

- Equipment may not be used without a written agreement and/or specific written permission.
- All applicable rules of TRRA and the national governing body (US Rowing or US Association for Canoe and Kayak) must be strictly adhered to by the lessee of TRRA equipment.
- Equipment must be inspected prior to lease noting its condition in writing and/or diagram and is to be returned in a condition which is at least as good as it was when taken out. (Please use the shell inspection form provided by TRRA).
- All equipment repair and/or maintenance problems are to be reported immediately using the appropriate forms.
- All persons leasing TRRA equipment are responsible for routine maintenance checks and reporting required minor repairs.
- Should equipment damage occur, an agreed upon offer to assist with the repair in a timely fashion is expected.
- The lessee agrees to pay the cost of the repairs, including the cost up to the insurance deductible, plus any un-recovered losses or damages.
- TRRA reserves the right to suspend or cancel this equipment agreement without notice and to refund any unused portion of prior payment for any reason, at its discretion, including the damage of the equipment or conflicts with the use of the equipment.
- A minimum payment equal to the insurance deductible and/or the term of the lease of TRRA equipment must be made *prior* to the equipment's use. An estimate of usage may be calculated with final tabulation after the use period. The payment equal to the insurance deductible will be refunded upon completion of use of the equipment and after the equipment has been determined to be in same condition it was prior to the lessee's use. All or part of the payment equal to the insurance deductible may be used to pay for damage or the insurance deductible should a claim be necessary.
- TRRA reserves the right to cancel this equipment agreement and to refund any portion of prior payment for any reason it deems as necessary including the damage of the equipment or conflicts with the use of the equipment by TRRA members or program participants.

This agreement applies to travel/race usage yes ___ no ___. The following additional terms apply to use of equipment for travel/race:

- TRRA equipment is intended for use by the members and program participants of TRRA. Under this agreement, affiliates may lease equipment for travel and/or to race if the equipment is not scheduled for use by any TRRA member or program and at the discretion of the TRRA equipment committee.
